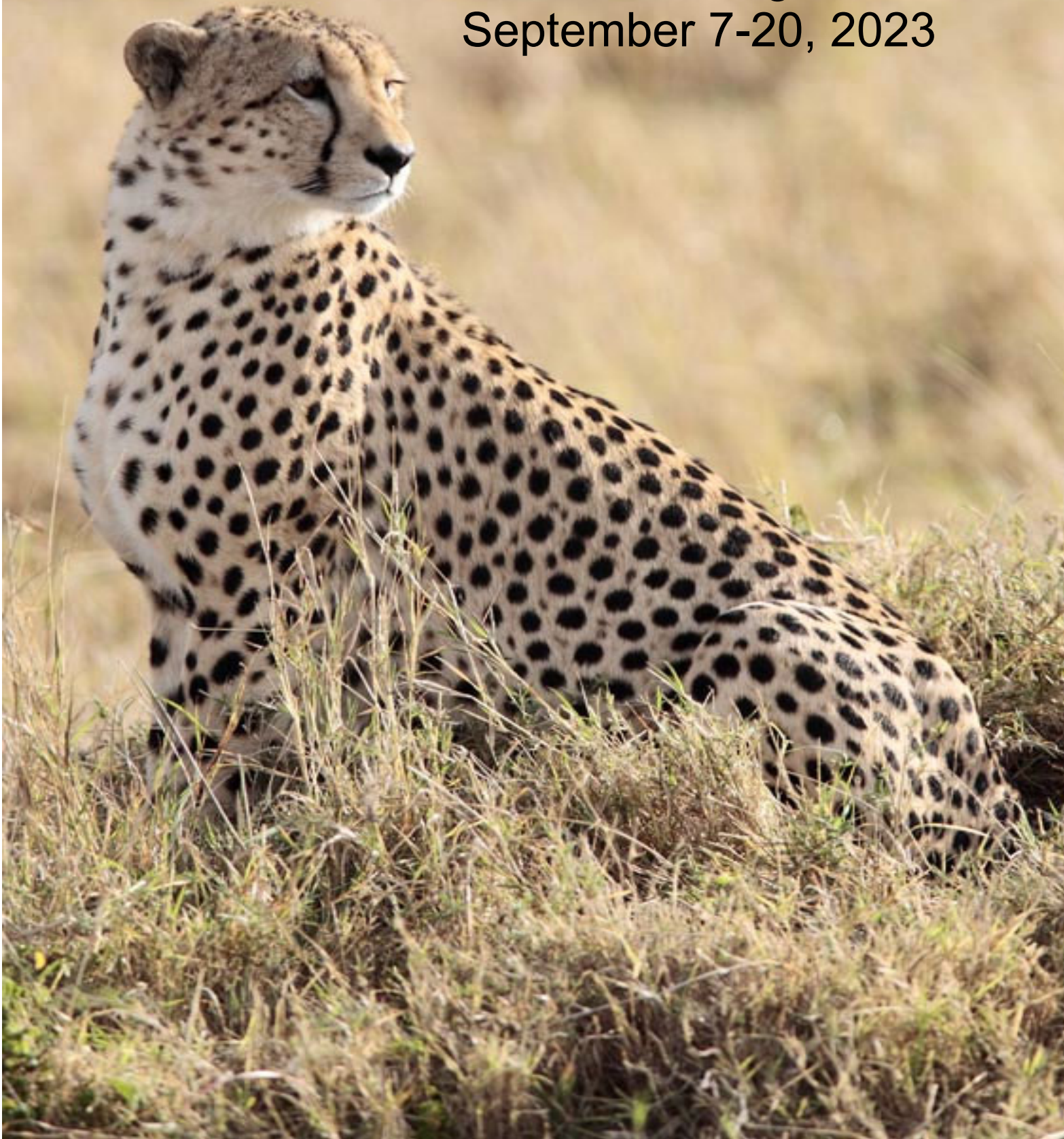


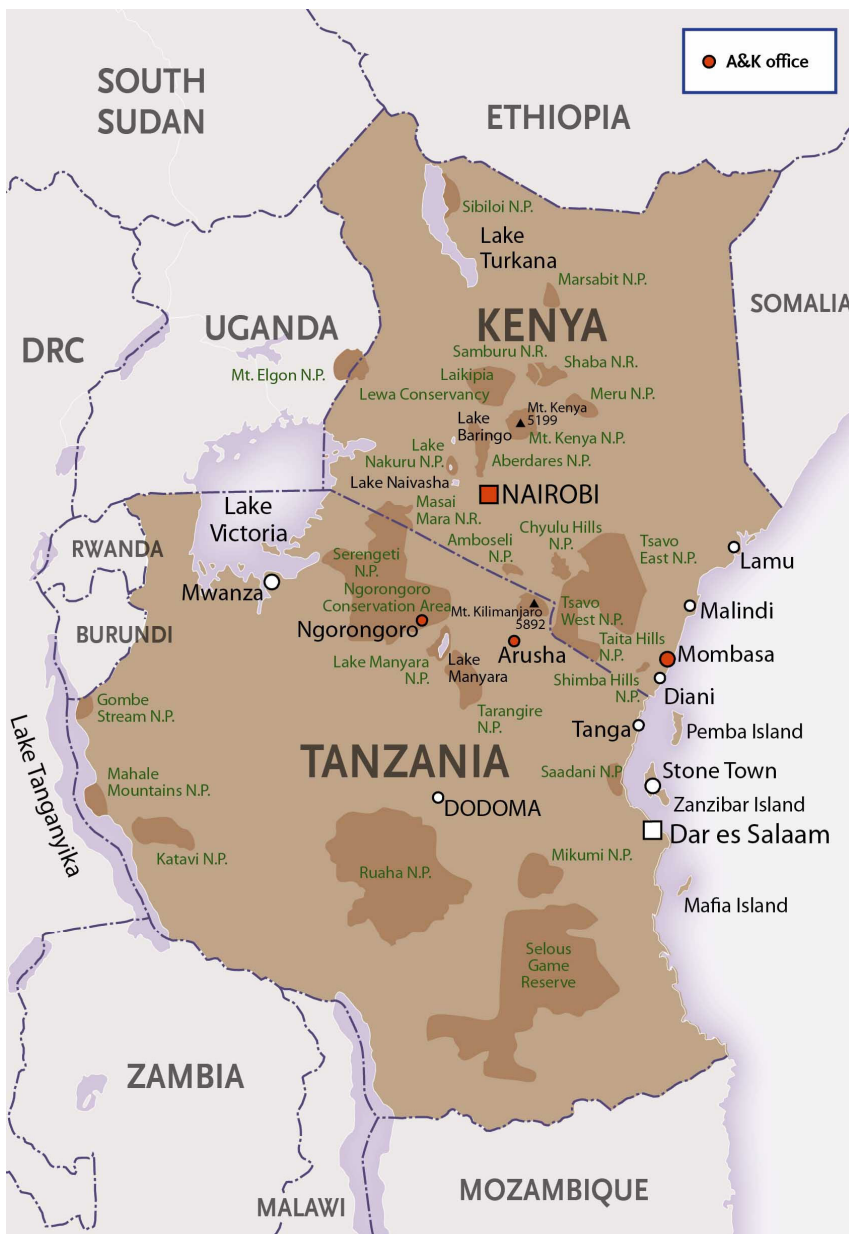

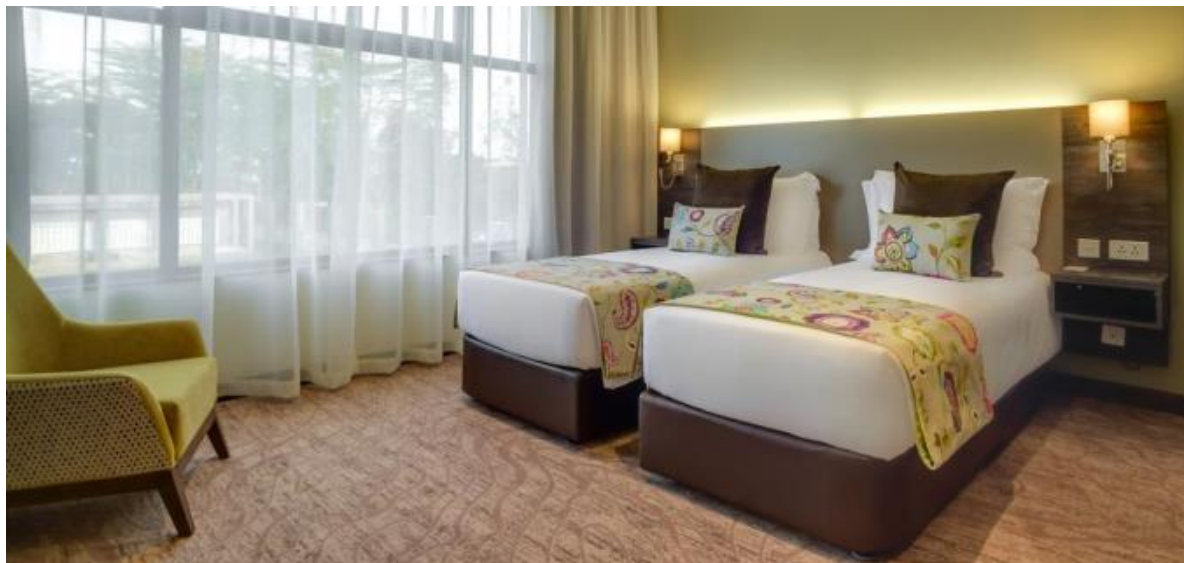

**Arrive Nairobi**

**Day 2**  
**Drive to Amboseli**

**B - L - D**

This morning drive to Amboseli National Park (approx. 4 ½hrs) with game viewing drive en-route to OI Tukai Lodge Lodge

OI Tukai lies in the heart of Amboseli National Park and is shaded by gracious acacia trees. Natural materials have been incorporated in both the public areas and the rooms, which are comfortable and airy. Most of the 80 chalet-style rooms face the majestic Mount Kilimanjaro and are serviced by friendly room stewards. A crystal clear swimming pool provides a refreshing welcome from the heat of the day and an ideal venue for an afternoon siesta.



In between game viewing, guests can watch animals grazing nearby (there is an electric fence) from the open-air Elephant Bar, enjoy a variety of board games in the lounge, or use the library which commands a beautiful view of Mount Kilimanjaro. On alternate evenings, guests can enjoy watching traditional dancing by the local Maasai.

There's time to freshen up before lunch is served. The early afternoon is free to explore your lodge or relax by the pool before taking a late afternoon game viewing drive.

**2 nights**

### Day 3

### **Amboseli National Park**

**B - L - D**

Spend the day exploring Amboseli on scheduled morning and afternoon game viewing drive.

Amboseli National Park, at the foot of snow-capped Kilimanjaro, Africa's highest mountain, lies 240 kilometers (145 miles) south-east of Nairobi. Years ago, this place formed the backdrop to the stories of famous novelists, Ernest Hemingway and Robert Ruark. For centuries, it has been the home of the celebrated Maasai, a proud nomadic people, famed for their courage and traditions. More than any other community in Kenya, they have learned to live in harmony with their environment and its resident wildlife. The park, almost 400 square kilometers (154 square miles), lies within an ecosystem ten times that size which spans the border with Tanzania and is host to dozens of species including big cats. Kilimanjaro can look like a mirage above the hot plains, so much so that early explorers wondered if they were seeing things and local chiefs sent their servants to the top to gather the silver they imagined they saw when the sun glistened on the ice. The ice, with no value to the chiefs of course, melts and becomes the precious resource upon which the game here relies, feeding rivers and swamps that sustain life during the long dry season. At this time the elephant appear ghostly white because of the pale dust they toss on their skins.



Amboseli showcases Africa at her big, beautiful best; the mountain, endless skies and sprawling plains. It is also home to plenty of smaller wildlife too and is one of the few places where the rare and beautiful Taveta Golden Weaver can be seen.

### **Oi Tukai Lodge**

#### **Day 4**

#### **Drive to Tarangire via Namanga and Arusha**

**B - L D**

After breakfast drive to Namanga, Kenya/Tanzania border town (approx. 2 hours) where you will be met by our representative who will assist you to clear immigration. From Namanga you will drive for approx. 2 hours in our vehicle before arriving in Arusha

Lunch at Gran Melia Arusha, then spend afternoon at leisure with optional activities

Gran Melia Arusha is set on 18 acres of beautifully landscaped coffee and tea gardens, with spectacular views of Mount Meru. A natural stream runs through the property adding to the tranquillity of its setting. The hotel has a total of 171 rooms with views of Arusha city or Mount Meru depending on your preference. Meals at Gran Melia are a treat, with eclectic dining options including Saba Saba, the all-day dining restaurant, Yellow Chilli, a specialty restaurant serving Indian cuisine and the Rooftop, offering Peruvian - Spanish tapas along with high energy cocktails. There is a gym and a pool for those who need to burn off some energy and a spa offering soothing treatments for those that need to unwind.





**Gran Melia Arusha**

**1 nights**

**Day 5**  
**Drive to Tarangire via Namanga and Arusha**

**B - L - D**

After breakfast drive to Tarangire arriving in time for lunch at Maramboi Tented Camp in Tarangire.



Tarangire National Park is one of the finest parks in Tanzania. Centered on the Tarangire River, this park has expansive views with wide panoramas of wooded savannah stretching in every direction. The most outstanding feature is the Tarangire River, which is permanent, and the only reliable dry-season source of water available to wildlife in a vast stretch of Tanzania's Rift Valley, attracting tremendous concentrations of animals.

Maramboi Tented Camp is a tented camp situated close to the shores of Lake Manyara and located on the migratory corridor of Manyara and Tarangire. The camp offers you the unique opportunity to experience and explore the area's interesting eco-system. The camp is in a wildlife rich area and offers impressive views of the Rift Valley and Ngorongoro Highlands.

The camp has 38 spacious tented rooms, individually built on a raised deck with en-suite bathroom. There are 6 family rooms, perfect for guests with children. The bathrooms have a built-in shower and each tent has its own terrace from where guests can enjoy views of Lake Manyara and the Rift Valley.

**Maramboi Tented Camp**

**1 night**

**Day 6**

**Enjoy game drive at Tarangire National Park, later in the afternoon proceed to Karatu Area**

**B - L - D**

As the sun rises above the ancient baobab trees, venture out into Tarangire in search of Lion and cheetah whilst large herds of elephant roam the park en route to their favorite swamp. Spend a day game viewing in the park with a picnic lunch to be enjoyed at a dramatic.



Later around afternoon proceed to Karatu Area to your lodge just before sunset to freshen up before dinner. A small and exclusive lodge facing the Oldeani Volcano, Ngorongoro farmhouse is only 5 kilometers from the Ngorongoro Loduare gate. The lodge was built to offer safari goers an original experience reminiscent of the atmosphere of the old days.



An oasis of calm, superbly located at the head of a beautifully fertile valley with the heavily forested slopes of the Ngorongoro Crater behind. Built in the early 20th century, the old colonial farmhouse has the comfortable atmosphere of a private house with roaring fires and friendly service and the rooms are set among flower-filled gardens. Fresh home cooked meals are served, with fruit and vegetables from the farm's organic garden. Coffee is grown, processed and roasted on the farm and guests wake up to the smell of fresh coffee, abundant flowers and wonderful views. You might like to walk to a nearby waterfall, winding in and out of the forest, surrounded by a multitude of birds and wildlife and see caves made by elephants, or simply stroll in the farm's beautiful gardens.



**Gibbs Farm**

**2 nights**

**Day 7**  
**Crater Tour and Maasai village visit.**

**B - L - D**

After breakfast, met by A&K driver guide and drive to Ngorongoro Conservation Area for full day crater tour. Your game drive today will be like no other as you visit one of the most dramatic safari

destinations in Africa, the Ngorongoro Crater. Descend to the crater floor in search of the big 5 with the back drop of the forest covered crater walls surrounding you, creating stunning back drops for all of your wildlife photographs. Travel through the Lerai Forest looking for leopard and onto the plains where the wildebeest and zebra graze whilst cheetah and lion lay and watch. Old elephants pass your vehicle whilst further afield rhino wander and hippos hide in the pools. A picnic lunch is provided so you can maximize your day in the crater.



### Gibbs Farm

#### Day 8 Drive to Serengeti National Park via Olduvai Gorge.

B - L - D

After breakfast, met by A&K driver guide and drive to Serengeti National Park with picnic lunch boxes via Oldupai Gorge, there's heaps to do here - you're close to the world famous two million year old Palaeolithic site of Ol Duvai, 'birthplace of mankind'



Thereafter, proceed to Serengeti with the game drive en route. The Serengeti, one of the planet's biggest and most enduring wildlife havens, stretches all the way from the Ngorongoro Highlands to Lake Victoria

(almost the size of New Jersey) and presents the oldest and largest ecosystem on the planet. It takes its name from a Maasai word, siringitu, "the place where the land moves on forever". Under an enormous African sky, the plains indeed seem infinite, as if a greater power announced to the resident wildlife, 'you can have all this', with the generous sweep of a celestial arm.



Serengeti ecosystem, an area that also takes in Kenya's Maasai Mara National Reserve, the Ngorongoro Conservation Area and the Maswa Game Reserve in the west. Within this 25,900 square kms of varied landscape live thirty-five species of plains game and 500 bird

Following breakfast, bid farewell to your lodge staff. You are transferred to the airstrip for your scheduled flight to Masai Mara.

Upon arrival into Tarime Airport, your guardian angel from Abercrombie & Kent meets and transfer you to Migori where you will be assisted with your connecting to the scheduled flight to Masai Mara (11:25 / 12:40 approximately).

Met on arrival by Mara Safari Club team and transferred to the camp.

Perched on the brow of the steep banks of the Mara River, in the Ol-Choro Oiroua Conservation Area, the Mara Safari Club offers a luxurious retreat on the edge of the world's greatest wilderness. With its grand dining rooms, spacious pool terrace, and varied nightly entertainment, the club is more of a luxury hotel than a tented safari camp - although, upon returning to your tent, you are immediately transported back into the African wilds. The 50 tents feature four-poster beds, electric lights, and modern en suite bathrooms, as well as dramatic views over the rushing brown waters below. The club's location outside the national park means that guests can enjoy walking safaris on the game-filled plains, as well as breakfasts and sundowners in the bush.



Enjoy a late afternoon game viewing drive in the Maasai Mara, a reserve abundant in plains game, predators and a myriad of birds.

**Fairmont Mara Safari Club**

**3 nights**

**Day 11 & 12**  
**Masai Mara National Reserve**

**B - L - D**

You have two full days to enjoy the sights and sounds of Maasai Mara on your early morning, late afternoon or full day game viewing drives.

The Maasai Mara plays host to the most spectacular array of wildlife. 1,500 square kilometers (580 square miles) of broad biscuit-colored savannah sprawls as home to huge numbers of birds (almost 600 species) and animals and is adjacent to the enormous expanse of the Serengeti; the two make up the most diverse ecosystem on the continent.

The word 'mara' comes from the local dialect, Maa, as spoken by the Maasai and means 'spotted'; certainly the vast grasslands here are dotted by the shadows of small clouds which scud across a huge sky above. Every year this special place witnesses the most incredible animal phenomenon on the planet - the wildebeest migration. The mass of plains game moving north from the Serengeti in search of fresh pasture returning south around October, a heaving line of grunting, snorting life that stretches for miles. At the Mara River they mass together nervously on the banks before plunging onwards; their pursuit of food overwhelming their fear of the crocodiles that lie in wait for the annual feast. This incredible spectacle involves the movement of over a million wildebeest and their fellow travelers, half a million Thomson's gazelle, half a million zebra as well as smaller herds of topi and eland all operating on the principle of safety in numbers. They are followed, inevitably, by predators, primarily lions and hyena.





**An optional Balloon excursion is available at an extra cost.**



*After around one hour the balloon lands and nearby breakfast is already being prepared. The smells of bacon, sausages and eggs drift on the breeze as you begin breakfast with platefuls of exotic Kenyan fruits and homemade pastries and, of course, glasses of bubbly to toast your flight in a tradition initiated by the Montgolfier brothers.*

*As the balloon is inflated against the first rays of sunrise your pilot will go through safety procedures. It's then time to climb aboard. Once aloft, the balloon floats gently over the plains, giving a bird's eye view of the game below as the sun creeps slowly over the horizon. Spread beneath you is a panorama of Africa - elephants looking improbably small; giraffe browsing amongst the treetops; antelope grazing; a pair of lionesses stalking a herd of wildebeest; an eagle guarding his eerie; and cheetah glancing up as the shadow of the huge balloon crosses their paths.*

A&K will of course make every attempt to notify you in advance of your trip as to whether such instances have had any effect on the accommodation or its surroundings if we are made aware of the same, however cannot be held liable in this regard.

### 15. SURVEILLANCE AND SECURITY

Please note that in some properties surveillance cameras and security equipment may be installed inside and/or outside the property, which may have the capability to remotely monitor or record images and/or sound. If you have any concerns or issues with this, you must inform our team before your trip.

### 16. ACTIVITIES

Some activities may be pre-booked by A&K however, should you wish to participate in other or additional activities we strongly advise that you book in advance so as to avoid disappointment.

Some activities, most notably those which are boating and water related, are subject to weather and water levels. A&K cannot be held responsible should such activities be amended and/or cancelled as a result of such matters, over which A&K have no control.

### 17. REGISTRATION:

A non-refundable deposit is required at the time of booking. The deposit amount will be specified at the time of booking, however it is normally 20% of the tour price.

The remainder of the tour cost is payable on the date shown on your quotation, normally 60 days prior to departure. If the reservation is made after this date, the entire tour price must be paid at the time of confirmation.

### 18. PAYMENT METHOD:

Payments may be made by the following methods:

- Credit card
- Cheque
- Bank transfer

A&K cannot guarantee that all payment methods will be accepted and A&K will therefore advise of the most suitable payment method at the time of deposit.

18.1 Travellers are liable for all bank and related transaction charges.

### 19. CANCELLATION:

All cancellations must be received in writing by your A&K Tour Consultant

19.1 Unless otherwise specified in your quotation, the following cancellation terms will apply to your booking:

19.1.1 Cancellations received between the date of booking and 61 days prior to departure will result in the loss of the deposit.

19.1.2 Cancellations received 60 - 46 days prior to departure will be subject to a cancellation charge of 25% of the tour price.

19.1.3 Cancellations received 45 - 29 days prior to departure will be subject to a cancellation charge of 50% of the tour price.

19.1.4 Cancellations received 28 - 15 days prior to departure will be subject to a cancellation charge of 75% of the tour price.

19.1.5 Cancellations received 14 days or less prior to departure will be subject to a forfeiture of the entire tour price.

19.2 Cancellation of airline tickets will be subject to the refund policy of each individual airline and may be greater than the percentages above particularly when low cost/net based fares are used.

19.3 The purchase of special event tickets is subject to the refund policy of each individual event. Please refer to the specific event policy for details.

19.4 A&K reserve the right to charge for financial penalties, fees and losses incurred in excess of your cancellation fee as a result of cancellation.

## 20. CANCELLATION BY A&K

We reserve the right in any circumstances to cancel your holiday for any reason. However, we will not cancel your hotel arrangement less than 60 days before your departure date, except for reasons of force majeure or failure by you to pay the final balance. If you fail to pay the balance of the holiday price at least 60 days before departure, A&K will treat your booking as cancelled and levy the cancellation charges set out in clause 19. If A&K is obliged to cancel your holiday in any other circumstances before departure, A&K will use its best endeavours to offer alternative arrangements of equivalent or very closely similar standard and price, if available; travel arrangements of a lower standard and a refund of the difference in price; or will give you a full and prompt refund of all monies paid.

## 21. FORCE MAJEURE

21.1 Force majeure means unusual and unforeseeable circumstances beyond A&K's control or the control of our suppliers, the consequence of which neither A&K nor its suppliers could avoid even with all due care, including, but not limited to, war, threat of war, riot, civil strife, terrorist activity (actual or threatened), industrial dispute, unavoidable technical problems with transport, machinery or equipment, power failure, changes imposed by rescheduling or cancellation of flights by an airline, natural or nuclear disaster, fire, flood, drought, adverse weather conditions, epidemics or outbreaks of illness and level of water in rivers.

21.2 In the event of a cancellation or material alteration to the trip as a result of the circumstances as described in this clause

A&K may in their sole and absolute discretion:

- a) offer the traveller(s) alternative travel arrangements or products of comparable standard as may be appropriate in the circumstances; or
- b) if alternative travel arrangements or products are not offered by A&K, A&K will make a prompt proportional refund of monies paid by the traveller.

21.3 A&K may charge a reasonable fee to cover the administration costs associated with providing alternative travel arrangements or products.

## 22. CLAIMS AND REFUNDS:

Refunds are not made for any missed services, except for verifiable extenuating circumstances. Please see our LIMITS ON ABERCROMBIE & KENT'S RESPONSIBILITY clause below. For verifiable claims to be considered, they must be received in writing within 30 days of the termination of the program. Any adjustment considered will be based on the actual price of the services involved and not on a per diem basis. Adjustments will not be made for unused sightseeing trips or meals. A&K will not accept any liability for any claims that are not received within 30 days of the termination of your program. All claims for days missed while travelling should be made in writing within 30 days of the program. Any payment made by A&K, either by way of refund or as the result of a successful claim, will be limited to, and not exceed, the sums retained by A&K in respect of the related booking.

## 23. LIMITS ON ABERCROMBIE & KENT'S RESPONSIBILITY:

Abercrombie & Kent Kenya Ltd, its employees, shareholders, officers, directors, successors, agents and assigns (collectively A&K), does not own or operate any entity which is to or does provide goods or services for your trip with the exception of a limited number of vehicles. It purchases transportation (by aircraft, coach, train, vessel or otherwise), hotel and other lodging accommodations, restaurant, ground handling and other services from various independent suppliers (including from time to time other affiliated Abercrombie & Kent companies). All such persons and entities are independent contractors. As a result, A&K is not liable for any negligent or wilful act of any such person or entity or of any third person.

In addition and without limitation, A&K is not responsible for any injury, financial or physical loss, death, inconvenience, delay or damage to personal property in connection to the provision of any goods or services whether resulting from but not limited to acts of God or force majeure, illness, disease, acts of war, civil unrest, insurrection or revolt, animals, strikes or other labour activities, criminal or terrorist activities of any kind, overbooking or downgrading of services, food poisoning, mechanical or other failure of aircraft or other means of transportation or for

failure of any transport mechanism to arrive or depart on time.

There are many inherent risks in adventure travel of the type involved here, which can lead to illness, injury or even death. These risks are increased by the fact that these trips take place in remote locations, far from medical facilities.

If you decide to participate in any activities including, but not limited to, any excursions involving animals, riding on animals, SCUBA diving, snorkelling, boating, hot air ballooning, zip-lining, high altitude treks, climbing, quad biking, para sailing, parachuting, kayaking, white-water rafting, primate tracking and any activity which A&K considers to carry inherent risks of serious illness, injury or death ("Activities") then you fully understand and acknowledge that Activities carry with them various inherent risks, including serious illness, injury or death and you take complete responsibility for your own health and safety and agree to assume all risks of injury, illness or death, whether foreseen or unforeseen that may befall you as a result of participating in any Activities and agree to release A&K and its affiliates, their agents, employees and representatives from any liability whatsoever related thereto, to the fullest extent permitted by law.

Further, as consideration for being permitted to participate in the Activities, you release A&K, whether known or unknown, from, and agree not to sue or make claim against A&K for property damage, cancellation of any activities for any reason, illness, negligent rescue operations or procedures, personal injury or death arising from your participation in the Activities, and any activity related thereto, including transportation to and from the site of the Activities, regardless of whether such property damage, illness, personal injury, or death results from the negligence of A&K (but not its reckless, wilful, or fraudulent conduct) and/or from any defect in equipment. You further agree to indemnify and hold A&K harmless with respect to any claim made against A&K by anyone else which a) related to your participation, or b) would be subject to the above release and covenant not to sue if you had made this claim directly yourself.

## 24. HEALTH PRECAUTIONS:

Please ensure that you consult your personal physician about anti malaria precautions and other inoculations and vaccinations before travel. Where applicable, please ensure that whilst travelling you carry a valid Yellow Fever certificate.

## 25. TRAVEL ADVISORIES/WARNINGS:

It is the responsibility of travellers to become informed about the most current travel advisories and warnings by referring to their respective government agencies. In the event of an active State Department or government agency Travel Warning against travel to specific destination location(s) of the trip, should the traveller still choose to travel, notwithstanding any travel advisory or warning, the traveller assumes all risk of personal injury, death or property damage

that may arise out of the events like those advised or warned against.

**26. TRAVELLERS' REPRESENTATIONS:**

If you or any member of your party has any medical problem or disability which may affect your stay, please provide us with full details before we confirm your booking so that we can try to advise you as to the suitability of your chosen arrangements. We may require you to produce a doctor's certificate certifying that you are fit to participate in the tour. Acting reasonably, if we are unable to properly accommodate the needs of the person(s) concerned, we will not confirm your booking or if you did not give us full details at the time of booking, we will cancel it and impose applicable cancellation charges when we become aware of these details.

**27. AIR TRANSPORTATION:**

**AIR TRANSPORTATION:** Airlines concerned are not to be held responsible for any act, omission or event occurring while passengers are not on board their aircraft. International air carriers are also subject to international air conventions limiting their liability. These limitations of liability are explained on the e-ticket or on the reverse of the airline ticket and when issued, this constitutes the sole contract between the respective air carrier(s) and their passengers.

Airlines overbook all flights! We therefore recommend that you check in online as soon as online check-in is made available by the airline. If you do not book in online, or for any reason are unable to do so, we recommend that you are at the airport to check in **3 hours** prior to departure as airlines may re-allocate seats in the event of late check-in and arrivals. A&K is unable to check you in and it is your responsibility to ensure you are checked in within the appropriate time. A&K is neither responsible nor liable if you are downgraded an airline class as a result of the airline overbooking the class in which you are booked. Seat reservations are at the discretion of the airline and may be changed at any time without notice.

**CRUISES/CHARTERS:** If you are scheduled to partake in a cruise or charter it is your responsibility to ensure that you are aboard

the vessel no later than 60 minutes before the scheduled sailing time. A&K is neither responsible nor liable if you fail to board the vessel in good time and suffer any loss as a result. Furthermore, refunds will not be given for any days which are missed as a result of such failure, or for clients who choose to leave the Cruise prematurely for any reason.

**28. PASSPORT & VISAS**

Please note that passport holders are responsible for obtaining the required documentation applicable for entry. Please note also that passports must be valid for at least six (6) months after completion of your journey and should also have sufficient blank pages for visas and immigrations stamps. A&K cannot be held responsible should you be denied entry to a country due to non-compliance with these requirements. **29. TRAVELLING WITH CHILDREN**

A&K cannot be held responsible should you or any member of your travelling party be denied entry to a country due to non-compliance with these requirements. **31. ARBITRATION AGREEMENT:**

Any claim arising out of or relating to these Terms and Conditions, to the Limits on A&K's Responsibility clause, to the brochure, to any information relating in any way to the trip, to the trip itself or to any products or services related to the trip, shall be settled in the first instance by binding arbitration in the applicable legal forum as detailed in clause 32 of these Terms and Conditions. In lieu of a personal appearance at arbitration the arbitration may be conducted by telephonic means. Arbitration is the exclusive forum in the first instance for dispute resolution and except as otherwise provided by statute, each party shall bear its own costs and expenses and an equal share of the arbitrator and administrative fees.

**32. APPLICABLE LAW AND FORUM:**

This agreement shall be construed, interpreted and enforced in accordance with, and shall be governed by the laws of Kenya. It is agreed between A&K and the travellers that all lawsuits against A&K arising under, in connection with, or incidental to the tour shall be filed, if at all, in the courts of Kenya to the exclusion of the courts of or in any other country or jurisdiction.
